NOTICE OF PERSON'S WISH TO BE PARTY TO PROCEEDINGS

Section 274, Resource Management Act 1991

TO: The Registrar

1. We Ngati Te Roro o te Rangi Hapu wishes to be a party to **ENV-2017-AKL-000147 Ngati Uenukukopako Iwi Trust v Bay of Plenty Regional Council** which relates to decisions on Proposed Plan Change 10 to the Bay of Plenty Regional Land and Water Plan (**Plan Change**).
2. Ngati Te Roro o te Rangi Hapu has an interest in the proceedings that is greater than the public generally on the grounds that:
 - (a) Ngati Te Roro o te Rangi Rohe has overlapping interests with other Hapu extending from the Waingaehe Stream to Tarawera Road, up Tarawera Road to the ridge of the Whakapoungakau Range, along the Range to Pukepoto, back down the Waingaehe Stream to Lake Rotorua.
 - (b) Ngati Te Roro o te Rangi as a Koromatua of Whakaue however, has customary interests rights around Rotorua-nui-a-Kahumatamomoe and

is one of six Koromatua who contributed 5000 acres to establish Rotorua City.

- (c) Ngati Te Roro o te Rangi is based from Owhata Marae at Hinemoa Point and has a second marae, Te Kuirau based in Ohinemutu and represents 2600 registered beneficiaries as recorded on the Te Pumautanga o Te Arawa beneficiaries list.
3. Ngati Te Roro o te Rangi Hapu is interested in all of the proceedings.
 4. Ngati Te Roro o te Rangi Hapu supports the relief sought and supports all the Appeal clauses in the Uenukukopako Appeal document.
 5. Ngati Te Roro o te Rangi Hapu agrees to participate in mediation or other alternative dispute resolution of the proceedings.
