

Resource Management Act 1991

The following application for resource consent has been received by Bay of Plenty Regional Council.

Nature of Application

The Applicant, Western Bay of Plenty District Council, is seeking a comprehensive stormwater discharge consent (Consent Application Number RM17-0121) which will manage stormwater from Te Puna and Minden (the 'Central' Catchments).

Consent is sought specifically for the following activities:

- To discharge stormwater to land, land where it may enter water, wetlands and surface water, from multiple locations;
- To undertake maintenance activities on the stormwater network, including ongoing operations and upgrades (replacements, demolition and improvements works), which require the following to be undertaken:
 - Land disturbance within the Coastal Marine Area (CMA);
 - Disturbance of the beds of water bodies and placement of structures in the beds of water bodies;
 - Discharge of sediment contaminated stormwater to land, water or land where it may enter water;
 - O Discharge of contaminants (such as herbicides) to land, water or land where they may enter water.

The Comprehensive Stormwater Consent (CSC) does not include land zoned Minden Lifestyle under the Western Bay of Plenty District Plan.

Location

Various locations throughout Te Puna and Minden (Central Catchments).

Submissions

The submission must be dated, signed by you and include:

- Whether you support or oppose the application.
- 4 Your reasons for the submission.
- 5 The decision you wish the Bay of Plenty Regional Council to make.
- Whether you wish to be heard in support of your submission.
