





QUARTERLY PATRONAGE - ALL SERVICES (EXCL MATAKANA FERRY)






Patronage All Services

Urban Services - Patronage






Urban Services – By Passenger







- Submissions/feedback e.g. Road to Zero




Customer Experience

Total Mobility




- Ridewise implemented in Nov19, 3,100 clients using new electronic system


RITS

- Important for accurate network status information for travellers and Transport team
- Project underway to fix current issues and improve guidance for using TransitApp
- Long term solution being scoped for Bay of Plenty may include other Regional Councils
