Application for resource consents to authorise the proposed upgrade of the existing Rotorua Wastewater Treatment Plant (WWTP) and a new discharge of treated wastewater - Lake Rotorua

("Applications")

- 2. The **Director-General of Conservation** made a submission on the Applications.
- 3. The **Director-General of Conservation** is not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.
- 4. The **Director-General of Conservation** is interested in all of the proceedings.
- 5. The **Director-General of Conservation** is interested in the issues identified in its submission on the Applications, and the following particular issues:
 - 5.1. Potential adverse effects on geothermal habitat and rare geothermal vegetation;
 - 5.2. Potential adverse effects on geothermal surface features, the geothermal systems of the Puarenga Sulphur flats and Te Arikiroa thermal channel and on other geothermal values;
 - 5.3. The risk of hydrothermal eruption and the ability of the recommended conditions of consent to adequately manage that risk;
 - 5.4. Potential adverse effects on avifauna, including on bird species that have the threat classification of 'Threatened' and 'At-Risk';
 - 5.5. Effects on water quality and freshwater values, including;
 - 5.5.1. Potential adverse effects of nutrient inputs to Lake Rotorua (nitrogen and phosphorus);
 - 5.5.2. Increased likelihood of localised algal blooms;

- 5.5.3. Appropriateness of discharge limits/standards for other water quality attributes.
- 5.6. The appropriateness of the chosen conveyance route and method, and whether alternative locations and methods of discharge that would avoid valued geothermal features and vegetation are available;
- 5.7. Ensuring the conditions of consent adequately address the ecological effects of the proposal, provide certainty, and include appropriate monitoring for all the potential adverse effects identified in this Notice,.
- 6. The **Director-General of Conservation opposes** the grant of the Applications because:
 - 6.1. In its current form, the Application is inconsistent with the provisions of:
 - 6.1.1. The purpose and principles of the Resource Management Act 1991 including Sections 6(a), (b) and 6(c);
 - 6.1.2. The New Zealand Policy Statement for Freshwater Management2014 including Objective A1 and Policy A4;
 - 6.1.3. The Bay of Plenty Operative Regional Policy Statement including policies El 5B, GR 4A, GR 9B, GR 11B, MN 1B, and MN B2;
 - 6.1.4. The Bay of Plenty Operative Rotorua Geothermal Regional Plan 1999 including Objective 13.5.1, and policy 13.5.2; and
 - 6.1.5. The Rotorua District Plan including objectives 1.2.1, 1.3.11, 2.3.1, 2.3.2, 2.3.4, 2.3.5, 2.3.7 and the associated policies.
- 7. The **Director-General of Conservation** agrees to participate in mediation or other alternative dispute resolution of the proceedings.
