

#### The benchmark for Toi Moana is a 5% return plus capital preservation.

As at 31 December 2020 the Toi Moana Fund was above benchmark running at a 6.95% IRR. The portfolio paid its first distribution in December (\$1,687,500).

The portfolio returned 8.56% in December and 18.34% for the year. The portfolio is currently yielding around 3.15%, showing the reliance on growth (capital gains) to reach the target return of 5%. There has





been minimal trading within the portfolio this quarter as we are happy that the shares owned are long-term and stable in nature (meeting the mandate requested). Despite the severe cuts in dividends across most listed companies announced in recent months, our estimates are that the current portfolio can sustain a 3.91% yield.

The portfolio has benefitted strongly from its core exposures (Meridian, Contact, Tilt), but was unable to take advantage of the price spike in early January as it was driven by a lack of depth; we did manage to sell 22,817 Contact Energy shares at \$10.47 (current price \$8.42).

### Distribution

We will look to pay the next distribution plus remaining catchup while market condition are favourable.
