June 2021



# What is Proposed Change 5 (Kaituna River)?

Proposed Change 5 (Kaituna River) to the Operative Bay of Plenty Regional Policy Statement has been notified and is now open for public submissions.

Proposed Change 5 (Kaituna River) seeks to fulfil Regional Council's responsibilities under the Tapuika Claims Settlement Act 2014 which requires it to recognise and provide for the vision, objectives and desired outcomes of *Kaituna He Taonga Tuku Iho - A Treasure Handed Down* (the Kaituna River Document) in the Regional Policy Statement (RPS). This is to the extent that the contents of the Kaituna River Document:

- relate to resource management issues of the region; and
- it is the most appropriate way to achieve the purpose of the Resource Management Act 1991 (RMA) in relation to the Kaituna River.

The Kaituna River Document was launched by Te Maru o Kaituna River Authority, a co-governance partnership mandated to restore, protect and enhance the environmental, cultural, spiritual health and well being of the Kaituna River. The Kaituna River Document took effect from 1 August 2018 following consultation with the community, hapu and iwi.

Since late 2019, Regional Council staff members have been working on developing Proposed Change 5 (Kaituna River). A draft version of the proposed change was open for public comment from 18 August to 16 October 2020. Twelve comments were received and the proposed change was updated in response to the feedback received.

Proposed Change 5 (Kaituna River) has been prepared under the RMA. It will be the second co-governance change to be included in the RPS and it is specific to the Kaituna River and its tributaries. It includes:

- 7 Kaituna River objectives
- 9 Kaituna River policies
- 6 Kaituna River methods of implementation; and
- Expansion of 5 existing methods to also apply to the Kaituna River.

Each objective is supported by a policy framework to promote their achievement. Neither the RPS nor the Kaituna River Document contain rules.

The Kaituna River is in a healthy state and protected for current and future generations.

## What are the issues?

## Proposed Change 5 (Kaituna River) includes provisions to address the following issues:

Water demand is high and could pose a risk for springs, surface water bodies and associated tangata whenua, ecological and recreational values

Urban growth, climate change, rural land use intensification

Water quality is declining and is not always suitable for swimming in locations people wish to swim

Waterbody modification impacts

Tangata whenua have become disconnected with the Kaituna River

Health of the Maketu Estuary.

# Proposed Change 5 (Kaituna River) Objectives

The traditional and contemporary relationships that iwi and hapū have with the Kaituna River are recognised, strengthened, enhanced and provided for

Water quality and the mauri of the water, including groundwater, in the Kaituna River is restored to a state which provides for ecosystem health, human contact, threatened species and mahinga kai values

There is sufficient water quantity in the Kaituna River to support the mauri of rivers and streams and provide for tangata whenua, ecological and recreational values

Water in the Kaituna River is sustainably allocated and efficiently used to provide for the social, economic and cultural well-being of iwi, hapū and communities now and for future generations

The environmental well-being of the Kaituna River is enhanced through best management practices

The Kaituna River's wetlands, aquatic and riparian ecosystems are restored, protected, and enhanced to support indigenous species

Te Maru o Kaituna collaborate with iwi and the wider community to enable environmental, economic, social, educational and cultural aspirations for the restoration, protection and enhancement of the Kaituna River.



# Proposed Change 5 (Kaituna River) and other processes


## National Freshwater Policy for Freshwater Management 2020 (NPS-FM)

The Regional Council is also working in the Kaituna River catchment to implement the NPS-FM. The NPS-FM requires a specific process for engagement and development of RPS and Regional Natural Resources Plan (RNRP) changes to give effect to its directions.

Regional Council has a separate *Essential Freshwater Policy Programme* for engaging with the community and tangata whenua as part of implementation of the NPS-FM. Region wide NPS-FM implementation will be delivered through RPS and RNRP changes which will be notified in July 2024. Regional Council's obligations to recognise and provide for the Kaituna River Document continue to apply when it changes the RPS and RNRP.

The purpose of Proposed Change 5 (Kaituna River) is to recognise and provide for the Kaituna River Document in accord with the Tapuika Claims Settlement Act (not NPS-FM implementation).

This diagram illustrates how Proposed Change 5 (Kaituna River) relates to the Settlement Act requirements and the RMA.



## **Timeline**

#### 1 August 2018

The Kaituna River Document comes into effect.

#### 18 August - 16 October 2020

Draft Change 5 (Kaituna River) consultation

#### November 2020 to March 2021

Consultation feedback is evaluated and Proposed Change 5 (Kaituna River) is updated.

#### 1 April 2021

Proposed Change 5 (Kaituna River) is approved by Regional Council.

#### 29 June - 10 August 2021

Proposed Change 5 (Kaituna River) notified and open for submissions.

#### September/October 2021

Further submissions.

#### November/December 2021

Documentation and nominations provided to the Chief Freshwater Commissioner. The FPP process commences.

### The Freshwater Planning Process (FPP)

Regional councils are required to use the Freshwater Planning Process to implement changes required by the NPS-FM and for any change to a regional plan or RPS if it relates to freshwater. As Proposed Change 5 (Kaituna River) relates to freshwater it is a 'freshwater planning instrument' and must follow this process process which is overseen by the Chief Freshwater Commissioner.
