A guide to the Bay of Plenty Regional Council Water Users Data Management System (WUDMS)

What is the system and why do we need one?

We have more than 1300 resource consents for water takes in the Bay of Plenty. Many of these require keeping records of water use and sending them to Council regularly. This information helps us manage water so that everyone continues to have a secure and sustainable supply. The information is used to prepare catchment and regional plans, and to assess water allocation.

We've improved the process for gathering this information.

The Water Users Data Management System (WUDMS) will make it easier for you to send us water records, and easier for us to receive them.

How can I submit data?

There are three ways you can submit data to us:



Electronic (automatic) submission

If you have a data logger on your pump, you can arrange to have data transfered to us directly. You do not need to enter any data and information will be uploaded and downloaded in real-time. You can do this yourself or use an external provider. Contact the Water Administration Team for more information.



Online (manual) submission

Entering the information online is much easier. Using a unique username and password, you can enter water records onto WUDMS through our website. This is ideal, both when you use the water take sporadically, such as through the frost season, or for daily or weekly use. Find out how to get started with online data submission overleaf. We are also trialling a text message service. Contact us to find out more.

Paper (manual) submission

You can continue to post, fax or email us your water records. Although you can still do this, we expect to phase this process out over time. A template for daily monitoring returns is on our website www.boprc.govt.nz > Environment > Resource Consents > Resource Consent Compliance

When does my data need to be sent to Council?


Check your consent conditions – many consents issued after November 2010 require data to be sent to us by the 10th day of the following month. Some require monthly or quarterly returns and some are required annually. Using the electronic methods, sending your data on time is now even easier.

Who is responsible for sending the data to Council?

As the consent holder, it's your responsibility to ensure the data is sent to us by the required date, even if you have an orchard or farm manager who completes and sends the return, or if you have a third party data provider.

Getting started with Water Users Data Management System (WUDMS)

Step 1

Accessing the website

- 1. Go to www.boprc.govt.nz.
- Go to the Water Metering page (Environment > Resource Consents > Water Metering). Click on the Water Users Data Management (WUDMS) link on that page.
- 3. Enter your Customer Number this is the same as your Regional Council debtor number (you can find this on your Council account).
- 4. Enter your password. The default password is "1234" and you'll be asked to change this to a unique password when you log in the first time.

Step 2

Entering your data

- 1. Click on the relevant consent number to enter readings.
- 2. Select the month and year for the data you wish to enter.
- 3. In the blue boxes, type your meter reading and hours pumped in the appropriate column. If you make a mistake, use the back arrow to return to the previous cell.
- 4. When you have completed data entry and you have checked that it is correct, press the submit button.

Step 3

Adding more readings, viewing data and sending us feedback

- 1. From the Consent Summary page you can choose to enter more readings or view previously entered data.
- If you are unsure about anything, you can email us using the CONTACT US button. For example, if a pump failed or frost protection has started, let us know.
