#### Key points included:

- Land Care Research was assessing gorse in the catchment via satellite imagery to determine any changes since 2014.
- 95% of >40ha property owners had engaged with Council to begin the resource consent process for Plan Change 10 implementation.
- Nine resource consents had been issued to date.
- Accounting for the attenuation factor of gorse had affected achievability of the 30 tonne target, unless alternatives were considered it was unlikely to be met.
