

### Status and commentary



#### The benchmark for Toi Moana is a 5% return plus capital preservation.

As at 31 December 2021 the Toi Moana Fund was below benchmark running at a 5.90% return (IRR). Please note that the IRR is a calculation that is inclusive of cash, taxes and capital gains. So while the return is over 5%, this does not quite equate to the 5% cash return that Council would like to achieve.





The portfolio returned 4.24% in December and 0.68% for the for the previous 12 months. The portfolio is currently yielding around 4.11%.

Recent changes to the SIPO has allowed international equities to be added to the portfolio (c. 10.6% as at December). It is anticipated that further capital will be deployed offshore in the coming months which will drive growth (capital gains) allowing us to meet the 5% mandate.

### Distribution

No distribution was made during the period.

### **Responsible investment**

Quayside in conjunction with its investment advisor (JB Were) completed a comprehensive review of both the Quayside and Toi Moana listed asset portfolio. The review compared all holdings as at 31 December against the New Zealand Super Fund Responsible Investment Exclusion List (February 2021). No breaches were identified.

All new investments have been screened for compliance with the Group principles of responsible investments.


