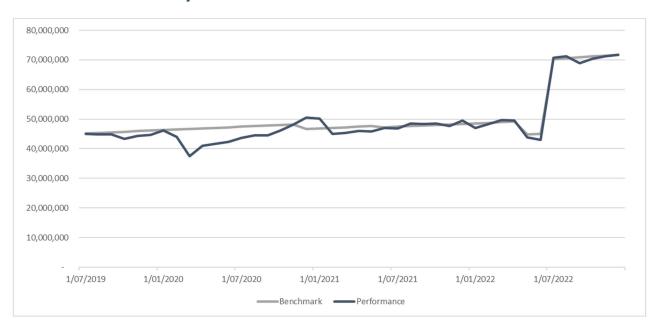

Status and commentary



The benchmark for Toi Moana is a 5% return plus capital preservation.

As at 31 December 2022 the Toi Moana Fund was below benchmark running at a 4.74% return (IRR). Please note that the IRR is a calculation that is inclusive of cash, taxes and capital gains. BOPRC has





been paid all cash distributions owing up until 30 June 2022 with another distribution scheduled for March 2023.

The portfolio returned 0.67% in October and 3.94% for the for the previous 12 months. The portfolio is currently yielding around 4.68%.

Quayside has continued to take advantage of the high inflationary environment and has continued to add further bonds to the portfolio, all of which are yielding comfortably above the benchmark return.

Distribution

No distributions were paid by Toi Moana Trust for the financial year. Quayside is planning to distribute \$1.75m based on the results recorded in the first 6 months of the financial year ending June 2023.

Responsible investment

Quayside in conjunction with its investment advisor (JB Were) complete a comprehensive quarterly review of both the Quayside and Toi Moana listed asset portfolio. The review compares all holdings against the New Zealand Super Fund Responsible Investment Exclusion List. No breaches were identified.

All new investments have been screened for compliance with the Group principles of responsible investments.

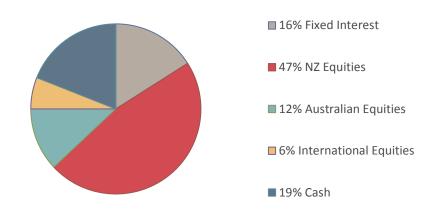

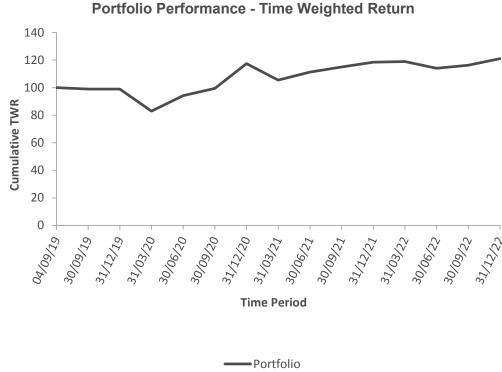

Price IRR return measures change in market value in the local currency.

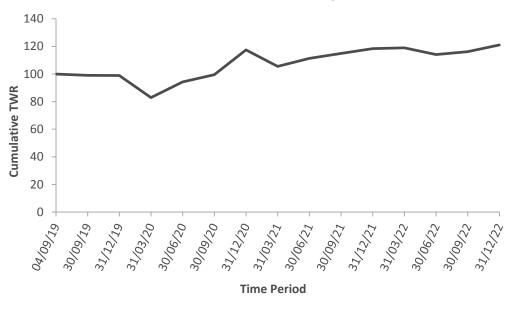
