



## **Resource Management Act 1991**

The following application for resource consent has been received by Bay of Plenty Regional Council.

### **Nature of Application**

The Applicant has applied for resource consent to discharge contaminants, being particulate matter 10 (PM<sub>10</sub>), odour, nitrogen dioxide (NO<sub>2</sub>), carbon monoxide (CO) and Sulphur dioxide (SO<sub>2</sub>), to air from the production of asphalt and associated yard activities at 92 Hewletts Road, Mount Maunganui.

Please note the Applicant previously held resource consent 63317 to undertake the same activity, this consent expired on 20 September 2020. The applicant lodged a replacement application more than six months prior to the expiry of their previous consent and therefore were automatically afforded the right to continue operating under their previous consent, under section 124(3).

### **Location**

The legal description of the site is Lot 2 DPS 69066 and the site is located at or about map reference NZTM 1882207, 5826632.
