#### Record of Consultation – Lake Aniwaniwa Gravel and Island Removal

# Background

As outlined in the Consent Application Consultation and stakeholder engagement regard flooding, groundwater issues and gravel removal have been ongoing for several years.

BOP Regional Council and SGLP have hosted a number of meetings with stakeholder groups and local staff are in regular contact with these groups discussing the issues.

A list of Consultation is tabled below and evidence of these meeting can be provided if required. A number of meetings have been recorded by the BOPRC.

As highlighted in the consent application an Expression of Interest to carry out the excavation works was advertised in 2020. It was planned at that time to proceed with the gravel extraction under the BOPRC Global extraction consent. At the time these efforts were frustrated by the lack of available contractors.

As a result of the recent changes in the consenting landscape regarding gravel extraction and discussions with the Bay of Plenty Regional Council at this stage it was considered prudent to apply for a separate resource consent.

Thanks very much for that advice Cindy. That advice has been most helpful. Clearly from an elver perspective we need to reschedule to the work till September – November to minimise impacts.

That period does conflict with the migration calendar (table S2 1 below) but I assume the blacked out exclusion periods are quite geographically-related so the whitebait and elver exclusions will be for more coastal reaches. Similarly the trout egg development exclusion period (table S2 2 below) will be further up the Rangitāiki catchment I assume?

Thanks Bruce

When we chatted on the phone I didn't realise the delta was above the hydrodams. I had made a connection in my brain that it was at the estuary, still in holiday mode! The locations of the elver releases is important for determining the likely impacts of the February to April timing for extraction. A couple of points for you to think about whilst investigating release locations:

- Elvers and juvenile eels are the key species of concern based on the location of the delta. In addition,
   Aniwhenua is the main dam elvers are released above in the Rangitaikei catchment. Between 2001 and
   2018, 27,623,000 elvers were released above Aniwhenua compared to 7,617,000 above Matahina (Crow et
   al. 2020) Recruitment of freshwater eels 1995–2018 (mpi.govt.nz)
- The braided delta channels with gravel/cobble substrate will likely provide very suitable habitat for elvers and juvenile eels to reside in. Therefore, it is likely eels will be present in the substrate year round.
- As such, it would be best if BoPRC could carry out the extraction before the elver migration season (i.e.
  September to November). Based on Crow et al. 2020 the elver trap and transfer programme operates
  between December and March each year. In 2020, longfin elvers were still being captured in the trap mid
  March. Hence, any extraction between February and April will likely be impacting transferred elvers that are
  still moving upstream and/or have chosen the delta as habitat to reside in.
- The closer the release locations to the delta, the more likely the February to April timing for extraction will remove habitat being utilised by elvers in particular.

Therefore, would it be possible to delay the extraction to before the elver migration season so that the eels have a chance to move further upstream? If not, the later you can do the works, the better.

Also, I would recommend an eel salvage operation be undertaken prior and during the extraction as I would envisage there will be good numbers of eels in the substrate being removed. I assume under the consent BoPRC holds for the extraction works there has been an assessment of the ecological impacts of the channel excavation and appropriate mitigation? I haven't seen the site first hand but from google earth it looks like optimal eel habitat so would anticipate the extraction could adversely impact the channels suitability as eel habitat.

As I said I would get back to you by COB today I wanted to pass on my thoughts for discussion and once we know where the release locations are we can firm up the best timing that is realistic for the council.

Hi Cindy. I appreciate your advice regarding the best window to carry out works in the Aniwaniwa delta area.

The work involves extraction of gravel from the river bed, using a long-reach excavator, to try to minimise flooding upstream of Kopuriki Road. The location for the extraction is shown in the map below: We are giving the contractor some choice with the alignment, but we expect the red/yellow alignment to be the most likely.

Consultation around the project is occurring with local Iwi, stakeholders and Kokopu Trust. Discussions with the Trust will include ensuring their trap & transfer location avoids the section extraction works.

Also attached is fish spawning and migration calendar and guidance from the Regional Natural Resources Plan.

The duration of the project, affecting the wet channel, is expected to be approx. 2 months. Our preferred window for the work is in the February, March, April period.

#### Tēnā koe Maramena

I am writing on behalf of Southern Generation Partnership Limited regarding proposed works to remove gravel from the bed of the Rangitiki River downstream of Rabbit Bridge. Given the many meetings and discussions in the past I am sure you are aware of the history of the issues with this sediment build-up and impacts on local landowners.

This work was originally scheduled to be carried out late last summer under the Bay of Plenty Regional Council Global River Works Consent but was delayed upon advice from NIWA and BOPRC to minimise the impacts on Tuna and the aquatic ecology. We understand that while the Global Consent is still in place further discussions have been held between Ngati Manawa and BOPRC regarding the renewal of this consent and protocols for gravel extraction into the future. In discussion with the BOPRC they expressed concern about the proposed works given the intent agreed around protocols for future gravel extraction.

In reference to our discussions today SGLP would like to request a meeting with Ngati Manawa and the BOPRC at your convenience to discuss these concerns.

Sorry for the late response. I have been on leave with Covid 19.

I have read through your document and I have noticed that there is no reference to the protection of the tuna and tuna habitat. The relevant clause is included in Clause 125 of the Ngāti Manawa Settlement Act.

How do plan to protect the tuna and tuna habitats?

We would not support the removal of wetlands or tuna habitats. I noticed that there is no reference to any river restoration, tuna habitat improvements, or ecology assessment.

In addition, we still await a proposal for the proposed use of gravel expected to be extracted. A proposal that is mutually beneficial as it was not clearly outlined in your application

Hi Maxeen

As a follow up to our application I understand from Craig and Maurice that there is not too much evidence of the Tuna downstream migration so far. As far as conditions for proceeding with any works along with the proposed observation protocols, we are happy not to start work until Maurice or Ngati Manawa are happy that the migration season has finished along with the other proposed observation conditions.

Our discussions with Fish and Game have focussed on upstream impacts on water levels (this should be minor at normal flows), duck shooting season and trout spawning. At this stage we should be able to work through these issues if we get the timing right. I am talking to DOC next week.

We are still trying to get an affected party signoff with all parties and dependant on the consenting process and contractor availability the work is likely to at best be delayed until mid to late May

Peter,

As part of our statutory responsibilities, we are required to liaise with the Department of Conservation to ascertain if we have joint perspectives and over lapping mandates within both the Conservation and Wildlife acts. I have been in discussions with Rebecca Hunter (DOC) regarding this draft application and AEE, and as she has indicated in her email to you previously, DOC – and from my perspective, Fish & Game – need to await BOPRC's interpretation of the Pioneer's proposal in line with the most recent NES-FW (wetlands) regulations. We will notify BOPRC consents team as to Fish & Game's statutory interest in Pioneer's application as an affected party – and then fully assess the application, AEE in conjunction to regulations/ regional plan rules at that time.

Regarding the draft AEE – I note there is no reference to prior gravel extraction works at Rabbit Bridge undertaken in 2009 and in 2016 and interpretation of the very minor monitoring undertaken at that time. I believe this should be considered.

To be clear to the applicant Pioneer – Fish & Game stand by our original statement that we will accept gravel abstraction on the TR (only) below Rabbit Bridge during the trout spawning season to the end of the current causeway. Our specific interests / issues lie with timing of the works around gamebird hunting opening (both two weeks prior and two weeks post the first Saturday in May annually); the duration time of the works – regardless of when due to sediment issues; but mostly the potential hydrological effects on the adjacent and upriver wetlands, and the removal of wetland habitat within the delta area. This last full point will have to be very clearly covered within the AEE to alleviate many of Fish & Game's concerns – which it is not covered currently within the draft AEE. Possibly some mitigation works may occur within the immediate area to improve facets of these wetland areas – which in the long term may benefit the parties, and species within these same areas ??

Lastly, I appreciate that Pioneer are endeavouring to liaise with stakeholders and affected parties prior to consent lodgement – but it is difficult to comment further without having the finalised consent application, AEE and supporting papers - as that is what we must assess our formal response on. Too many variables / versions occur, and misinterpretation can occur (both agreement and opposition etc). Consequently, we will await the final versions before we can submit / comment further.


Figure 10: View of newly deposited woody debris in the delta area.
