The following application for resource consent has been received by Bay of Plenty Regional Council.

Nature of Application

Lawter NZ (the Applicant), has sought resource consent from the Bay of Plenty Regional Council to continue undertaking the discharge of contaminants to air associated with their on-site processes including processing of Crude Tall Oil, Crude Sulphur Turpentine, and other ancillary activities. These contaminants include Sulphur Dioxide (SO₂), Particulate Matter (PM_{10} , $PM_{2.5}$), Nitrogen Oxides (NO_2), and odour. The Applicant currently holds resource consent 61693 which enables this activity. This consent expired on 30 June 2020, noting the Applicant has s124 rights to continue with the previously consented activity until a decision is made on this application.

Location

The site is located at 211 Totara Street, Mount Maunganui, legal description, Lot 1 DPS 32302 and located at or about map reference NZTM 1881217 E 5826385 N.
