## **Nature of Application**

Ecocast Limited has applied for resource consents to expand their existing vermicomposting activity (resource consent 65549) both on the existing site and on a new proposed adjoining site in the Tarawera River Catchment at 296A Tarawera Road, Kawerau. Resource consent is sought for the discharge of contaminants to land where they may enter groundwater and surface water and to air encompassing both the existing site and the additional new site.

This is an application to replace consent number 65549 which expires on 31 October 2024.

### Location

The legal description of the site is Putuaki Block, Lot 3, DP 308053 and the site is located at Putauaki Block, McKee Road, Kawerau or about map reference NZTM 1928448, 5779766.
